Bylaws: Section 9. In order to participate in the screening process, or vote on the Endorsement Committee’s recommendations, a member must be a dues-paying member in good standing at least 30 days prior to the endorsement screening. A membership list will be used to determine eligibility to participate in screening or approving the list of candidates recommended by the Endorsement Committee. This will eliminate “special interest” drop-ins and drop-outs.
