Over the course of 2 weekends the Endorsement Committee led the 2024 endorsement screenings. We screened 56 candidates across 26 races. Ultimately the screenings led to 25 individual candidates being recommended, 1 no endorsement, and 1 ballot warning.

Additionally, we have 17 candidates who are unopposed, seeking re-election to their same seat, that were previously endorsed by Stonewall. We refer to them as UPE's. Bringing the total number of candidates we are recommending to 42.

In addition, the Endorsement Committee met on the evening of 01/14/24 to discuss the screenings. After conversation and a vote, the committee **decided to separate the HD-115 race** from the slate we are sending to the Executive Board and ultimately membership.
